



Information on the allocation of a slot pool at Paris Orly airport for S25

01/12/2024

As a consequence of the loss of the historical precedence of slots previously held by some airlines operating at Orly airport (ORY), some other operators who decided not to operate at Orly airport anymore, and some routes were reduced or stopped by some carriers, a pool of **8112** slots was made available for reallocation.

COHOR, the Paris-Orly airport coordinator allocated the entire pool on an annual basis considering the requests on waiting list for the Summer 2025 scheduling period (S25).

- EU regulation 95/93 Article 2 (b) : Definition of new entrant
 - EU regulation 95/93 Article 10.6 :
 - 50% of the slots placed in the pool shall first be allocated to new entrants, 50% to other carriers
 - Among requests from new entrants, preference shall be given to air carriers qualifying for new entrant status under Article 2 (b)(i) and (ii) and Article 2 (b)(i) and (iii).



Carriers which are now receiving slots from this pool and willing to start their operations during the present Winter 2024-2025 scheduling period (W24) could be allowed to do so.

These carriers will get the quota reserved for their year-round services (Summer 25 and Winter 25), subject to their request for Winter 25 season.

If any beneficiaries withdraw by the HBD (January 31, 2025), COHOR may reallocate the corresponding slots to other candidates on the waiting list.
